
On Christmas Eve 2011, I was riding with my cousin Eric Thomas (approximately 38 years old) in a rental car near Hwy 59 at the Porter Exit. We got stopped by the State Troopers and when Eric stopped the car, I ran because I had smoked some weed. I ran down the underpass and got into some woods. When I was running down the underpass, I kept falling. When I got to the bottom, I looked around and ran into the woods. It was about 7:00am in the morning and had been light for about an hour. I ran through the woods and came up on an overpass. It was a sidestreet and not 59. I couldn't go nowhere. I wasn't going to jump in the water because it was real cold so I ran up to the top of the train tracks. I heard the dogs barking and I called my girlfriend, Pleadeath Slaughter. She was my wife at the time and legally were still married but not together anymore. I told her what was going on and where I was and that I was hearing the dogs and they were coming. I was hiding up under the elevated train tracks. There was a bayou or creek right next to where I was hiding.

I heard officers yelling at me and I didn't think they could see me. When they said they were going to hit me with the taser, I knew they actually saw me. As I was coming down, they tased me. Im not sure how many times they tased me. I didn't resist because I didn't have a chance to resist. I was halfway down when they tased me. I fell 7-10 feet. They handcuffed me. I guess when they handcuffed me, I came back. I felt like I had blacked out.

When I woke up, my head was next to the creek. My right shoulder was messed up real bad. A couple of different people were screaming at me and asking me about drugs. I said I aint got no drugs, then one officer put my head in the water. I couldn't get up because of the way I was on the ground. He kept my head under the water for 2 or 3 seconds. It seemed like forever. They kept asking me about the drugs. He for sure dunked my head under water 2 times, maybe 3. At the time, I felt like he was doing it because I ran from them. I thought they were going to kill me. I was scared. I felt like I was going to drown.



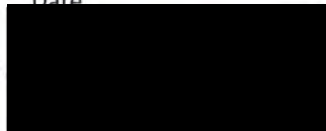
